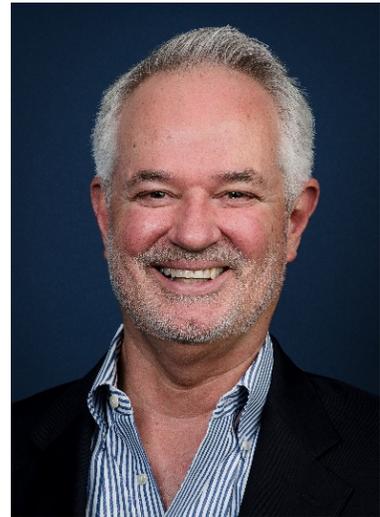

DIRECTOR'S MESSAGE

When the Ever Given container ship blocked the Suez Canal for nearly a week in late March, the world zeroed in on the logistics industry. Ships rerouted around the African continent to avoid the congestion and as many as 367 ships waited to pass through the canal at one time. The situation gave us more than a week of internet memes—it showed how fragile and overstretched our global supply chains really are.

We need to make our supply chain more resilient, sustainable and inclusive, and the Utah Inland Port Authority is focusing efforts on partnerships and infrastructure that will shorten and stabilize our supply chain. The Authority is focused in on a two-prong approach: 1) promoting use of rail to transport existing volume and 2) establishing Salt Lake City as the preferred route between U.S. west coast ports and Chicago.



We continue to work on reducing truck parking in neighborhoods, and this month's issue of The Input explains some truck parking terminology. Our partnership with SecūrSpace focuses on finding locations for safe and secure truck parking across the state so that truckers can plug into auxiliary stations and turn off the ignition during rest periods. The average trucker spends +/- \$30 in fuel when idling overnight, and this program is one way we're working to both improve our air quality and reduce fuel costs for truckers.

UIPA is excited to travel to in-person conferences and events again—if you see us, come say hello. We're moving forward to make Utah a leader in revolutionizing global logistics for the next generation.

TRADE TALK

The logistics industry has a lot of trade-specific terms, so we're here to highlight a few and show their relevance to Utah. In this issue, we're learning about **truck parking**:

Shore Power: the process of providing electrical power from the shore to a ship while it's docked, thereby allowing a ship's auxiliary engines to be turned off and the burning of diesel fuel to cease. Also known as cold-ironing or alternative marine power ([Clear Seas](#)). It is more commonly referred to as "truck stop electrification" in trucking.

Truck Stop Electrification (TSE): provides power outlets at truck parking spaces in which truck drivers can simply plug in, and turn off their engines, rather than idle their truck engine ([Inbound Logistics Glossary](#)).

Auxiliary Power Units (APU): a small, efficient motor that is capable of producing the power needed to keep the air/heat running, interior appliance power, etc. without the need to run the truck's engine. It is mounted on the side of the truck just behind the sleeper cab for convenience to access for fueling ([TAFS](#)).

Connection to UIPA:

The Authority is focused on promoting policies and programs that create efficiencies, fluidity, and sustainability within the logistics system. A smart truck strategy is critical to this system. One of the most immediate priorities is to expand the availability of truck parking options. There is a significant need for overnight parking in the Salt Lake area, as well as state-wide.

UIPA has partnered with SecurSpace to expand the availability of overnight parking across the state. This partnership will allow trucks safe places to park out of neighborhoods, off the side of roads, and turn off their engines. Plugging into APUs or shore power in secure lots provides safety for our truck drivers while also reducing fuel costs and air emissions, creating long term benefits for everyone.
